1. Always Lead by example as well as ensure team members, parents and fans adhere to Scottsboro Parks and Rec **C.A.R.E.** values.
2. Always demonstrate and develop the character traits of patience, perseverance, kindness, integrity, self-control and teamwork while inspiring an enjoyable and positive learning environment.
3. Always teach the athletic skills associated with the sport in an encouraging manner.
4. Always communicate respectfully with all participants and officials.
5. Always demonstrate and promote a positive attitude of **excellence**.
6. Provide an *sports environment for my team that is free of drugs, tobacco, alcohol and abusive language while refraining from there use at all sporting events.*
7. *Ensure that my players are supervised by myself or another designated adult and never allow my players to be left unsupervised at a game or practice.*

Coach, I also understand the following guidelines for punishment for violation of this coaching contract:

*An ejected coach must pay a \$50 fine, serve a 2 game suspension and meet with the Outdoor Rec. Coordinator prior to returning to coach any games. *Any coach who is ejected a second time will be banned for the remainder of the season and will subject to a \$50 fine before they will be allowed to coach any team associated with thand probation for the remainder of the season. Maximum: Suspension from all Rec * Com activities for a period of one year and probation the following year.e City of Scottsboro Parks and Recreation.

*A coach who displays conduct that the Athletic Coordinator or other staff members view as inappropriate can be punished as determined necessary by the Athletic Coordinator and Director of Parks and Recreation. This includes removal from coaching duties for the season or permanently. *Alcohol/Drug Policy: Teams/Individuals/Spectators/Coaches suspected of alcohol or drug consumption will be asked to leave the playing area and may be barred from further participation. The goal of disciplinary decisions is to encourage responsible behavior, maintain social order and protect the rights of others. Penalty for violating policy will be Minimum: Suspension from (2) league games
